2. I KNOWINGLY AND FREELY ASSUME ALL RISKS, both known and unknown, of participation in the Bumper Car / Bubble Soccer Ball / Human Bowling Ball / Foot Dart programming, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for participation.
3. I willingly agree to comply with the stated and customary terms and conditions for participation in the Bumper Car / Bubble Soccer Ball / Human Bowling Ball / Foot Dart programming. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS, the City of Providence, Providence Parks Department, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of premises used to conduct the event ("Releasees") WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. In further consideration of allowing me to participate in the aforementioned activities, I hereby agree to submit to binding arbitration any and all claims which I believe I may have against the RELEASEES or ALEX AND ANI City Center arising from my activities at the ALEX AND ANI City Center.

Arbitration shall be commenced within one (1) year from the date on which any alleged claim first arose.
